Dear Dean Ibañez,

It is my pleasure to inform you that the sixth year review team recommendation to extend maintenance of accreditation for the undergraduate and master's degree programs in business¹ offered by Pontificia Universidad Católica de Chile is concurred with by the Maintenance of Accreditation Committee and ratified by the Board of Directors. Congratulations to you, the faculty, the students, the staff, and all supporters of your School.

One purpose of peer review is to stimulate further continuous improvement of quality programs. As noted in the team report, your School is to be commended on the following strengths and effective practices:

- 1. Overall strong student satisfaction across all undergraduate and graduate programs.
- 2. Recent additions of young tenure track faculty members to assure proper succession and initial development of a stronger research culture.
- 3. PUC-SBA has made great progress in establishing a culture where assessment is important and in developing some excellent "best practice" models for AoL.
- 4. Dedicated activities to coaching, mentoring and advising students across the vocational, psychological, and physical dimensions of their life while at the school
- 5. Focus on analytic-quantitative thinking inculcated across all programs and that is considered a key differentiator for them over competitor schools in the region
- 6. The clear and creative interaction between the SBA and the Alumni foundation as a way to foster faculty development, infrastructure management and fund raising campaigns

Additionally, in the interest of continuous improvement, Pontificia Universidad Católica de Chile should closely monitor the following items, as identified within the Peer Review Team Report, and incorporate them in your ongoing strategic planning initiatives:

- 1. Continue to align with Faculty Sufficiency requirements. (Standard 9: Faculty Sufficiency)
- 2. Progress in research and publication in Peer Reviewed Journals. (Standard 2: Intellectual Contributions)
- 3. Further internationalization and diversity of the student body and faculty. (Standards 1-5

- 4. Inclusion of management specific courses in the Ingeniería Comercial-Administración program. Standards 15-16: Assurance of Learning)

Pontificia Universidad Católica de Chile has achieved accreditation for five additional years from the time of the original visit. The next on-site maintenance review occurs in the fifth year, 2014-2015. A timeline specific to your visit year is attached2. Please note that your Maintenance Review Application will be due on July 1st, two years prior to your review year. This application initiates the maintenance process. In this application you will be expected to provide progress on the strategic management initiatives at your school, with a particular focus on those continuous improvement items identified during your last maintenance visit.
